ORDER:

The Commissioner and Director of Municipal Administration, Hyderabad in his letter 1st read above, has informed that Government has allotted land to an extent of 20 Acres for establishment of National Institute of Urban Management in Sy.No.41/14 of Kanampet Village, Serilingampally Mandal, Ranga Reddy District which will act as resource center to enhance the Capacity of Urban Managers. He has further stated that the project steering committee of APMDP in the meeting held on 04.06.2013 agreed in principle for the construction of the compound wall around the NIUM site and the chairman of the Steering Committee advised that the construction work may be taken up by Engineer-in-Chief (Public Health) as per the World Bank procurement procedure.

2. The Engineer-in-Chief (Public Health), Hyderabad furnished his report along with estimates for construction of the compound wall with CRS masonry wall costing Rs.302.32 lakhs.

3. In his further proposal the Project Director, APMDP in his letter 3rd read above, has informed that in the meeting of NIUM Campus Development Committee meeting held on 08.01.2014 in the chambers of Principal Secretary (MA) it was decided that the funds for the above work will be met from the funds provided by Centre for Good Governance and requested to accord administrative sanction for construction of the compound wall.

4. The Government after careful examination of the proposal of PD, APMDP hereby accord administrative sanction for an amount of Rs.302.32 lakhs for construction of the compound wall with CRS masonry in the vacant land allotted to NIUM and this amount shall be provided by Centre for Good Governance.

5. This order issues with the concurrence of Finance (Expr.M&F) Department vide their U.O.No.2672/601/A1/Expr.M&F/2014, dated 03.02.2014.

6. The Commissioner and Director of Municipal Administration, Hyderabad and Engineer-in-Chief (Public Health), Hyderabad shall take necessary action in the matter.
